2279/25) To receive the Chair's report

The Chair reported that as complaints have been received, a letter will to be sent to the landowner regarding the path between Yew Tree and the school. The grass cutting season had started, with JWS carrying out the grounds maintenance. The £300 promised from Starbucks had been received, and will be used towards defibrillators/first aid for the village

2280/25) To receive reports from the District and County Councillors

Cllr Adams reported that the Brough Lane planning application would now not be heard at the planning committee meeting on 23 April, but by a planning officer before the end of the month. Further reports of anti-social behaviour had been reported, along with land encroachment in the field. In other areas, the CCTV proposal from Elkesley Parish Council would be followed up, with the hope that examples of fly-tipping and ASB would decrease. Cllr Adams had been visiting several operations on Jockey Lane with regard to enforcement issues.

2281/25) To suspend the meeting to hold a 10-minute public session

Questions had been put to District Cllr Adams during his report. Other matters raised included the purchase of a burial plot in the cemetery, and motorised toys in the fenced off part of the play area.

Currently awaiting a decision from the Inspector, with the next step being a referendum.

No issues, and a site visit by councillors on 8 May will address the matter of cremated remains

c. Defibrillator inspections

All ok, however the cabinet at the shop will need replacing in due course. Spare pads are to be obtained for all three devices

2288/25) To receive highways and service faults

Parking on the verges on Jockey Lane and other issues are still pending, following the site visit last month.

2289/25) To receive items for information only

Cllr Skelton reported that the recent party at the village hall was very successful, with £1500 raised for the Air Ambulance. It is hoped that more such events can be arranged, for example a summer fayre, fireworks event.
